**The Minnesota Sexuality Education Resource Review Panel **Recommends** the use of this curriculum for the following reasons and with the following reservations:**

#### **Review Summary:**

The Wise Guys Male Responsibility Curriculum is an eight to ten week program designed to teach young males self-responsibility, primarily in the areas of sexual development and health. The curriculum states that it can be offered in any setting where “young men gather to learn and grow with the guidance of trusted adults.”

The panel found the information in the curriculum technically accurate, up-to date, and presented in a way that used sound educational methodology. They felt that it was teacher friendly, however, recommended that the teacher/leader have strong content knowledge and group leading skills.

The panel felt that although the curriculum presented positive messages about sexuality, there were limited references to GLBT relationships and issues. Midway through the curriculum, the authors do recommend that facilitators use inclusive language in recognition of the fact that there will likely be members in the group who are questioning their sexual identity. The panel felt that although this was well stated, it should be stated earlier and should be better reflected in the language used throughout the curriculum.

The panel expressed concern that the curriculum perpetuated many gender stereotypes and was not racially, ethnically and culturally diverse. They felt that the age of the target audience was too broad and that it would need modifications dependent upon the actual ages of the participants.

The panel commended the fact that the curriculum focused on men. Very few curricula exist that are specifically directed towards adolescent males.
