The Minnesota Sexuality Education Resource Review Panel **Recommends the use of this manual for the following reasons and with the following reservations:**

This manual offers twenty-nine (29) lessons, each designed to examine issues related to abstinence, contraception, sexual health, pregnancy prevention, and STI and HIV/AIDS prevention. Each lesson includes the objectives, rationale, materials needed (including worksheets and handouts), and a step-by-step guide to conducting a successful session. This is not a comprehensive curriculum, but rather is a resource to supplement/expand existing sexuality education curricula.

The panel found the manual to be accurate, varied, thought provoking and teacher friendly. Lessons can be easily tailored to meet the needs of the audience according to age, community norms/values, learning style, etc. Panel members felt that the manual contains a variety of easily implemented activities that raise important issues, promote discussion and present good information. Panelists found the introductory information particularly helpful and recommended that it be read by anyone using the manual.

The panel recommended that the Contraceptive Options Chart be updated to include the newest information on contraception (e.g. Norplant is no longer available).

Overall, the panel found this to be a valuable resource that would work well within many settings.
