**The Minnesota Sexuality Education Resource Review Panel **Recommends** the use of this game for the following reasons and with the following reservations:**

This game is a discussion-oriented activity that educates players with “feelings” and “facts” cards. Because of the opportunities this game gives students to express their feeling on a wide range of topics about sexuality, the panel thought this would be an interactive way for teachers to assess the educational level of the students. It is appropriate for middle school students, but could be modified for a younger group. The rules offer teens flexibility by encouraging them to talk as well as take the opportunity to “pass.” The panel felt that an educator could creatively adapt the structure of the game to meet the needs of the group.

Some panel members expressed concern that the African themes and sayings may be too complex for teenagers and make the game feel Afrocentric rather than global or international. The panel found the instructions to be confusing and recommends that the facilitator become thoroughly trained and familiar with the game prior to using it in the classroom. This game is not recommended for one-time presentations but only for established groups.
